Statewide Emergency Repair Program Launches to Help Homeowners



DSHA is launching the Statewide Emergency Repair Program to address emergency conditions threatening

the health or safety of qualified Delaware homeowners and members of their households.

The program is administered by the Milford Housing Development Corporation. If you have an emergency or know someone who does, call (302) 491-4010 or toll-free (844) 413-0038.

Do I Qualify?

To qualify for assistance:

- Have valid proof you own your home and have resided there for at least 1 year
- Provide information that shows you and your household meet income guidelines

What Kind of Situations Qualify?

Immediate health or safety threats like:

- Heating system (winter months)
- Plumbing repairs (non-functioning)
- Electrical repairs (hazard exists)
- Roof repair/replacement (active leak)
 - Major structural repairs
- Urgent accessibility modifications (letter of necessity required)

Additional restrictions may apply.
