

HUD Awards Homeless Grants

The U.S. Department of Housing and Urban Development recently awarded \$7.95 million grants to support 31 homeless housing and service programs in Delaware. The Continuum of Care grants support local homeless programs across the country, with \$2 billion going to 7,300 programs nationally this year.

"The good work underway in Delaware is evident given the First State is one of only three states in the nation to have <u>effectively ended veteran homelessness</u>," said Joe DeFelice, HUD regional administrator for the Mid-Atlantic region.
