### Preserve at Whatcoat Grand Reopening



DSHA Director Anas Ben Addi and Governor John Carney recently celebrated the grand re-opening of The Preserve at Whatcoat, a 78-unit community along Saulsbury Road in Dover. The homes were recently renovated inside and out, and a community center and tot lot were added. DSHA helped finance the \$17.5 million renovations with \$3.7 million from the Housing Development Fund and \$9.4 million from the federal Low-Income Housing Tax Credit program.



The application process is now open for the 2018 Low-Income Housing Tax Credit program, which provides funding to developers of multifamily affordable rental housing. [All LIHTC applications are due to DSHA by 3 p.m. April 30.](#)

The [Qualified Allocation Plan](#) has been approved and is available for review. All applicants should review the QAP, guidelines, and LIHTC application thoroughly.
