Director Ben Addi introduced Senator Coons for his remarks to the NCSHA's annual Legislative Conference in Washington, D.C. Senator Coons is a longtime advocate for the HOME and CDBG programs stemming from his prior service as New Castle County Executive and as County Council President.

He spoke about the outlook for housing issues in Congress from his perspective as a member of the Senate Appropriations Committee on Transportation, Housing and Urban Development. He has served in the Senate since 2010.



Strong Neighborhoods Work Underway in Wilmington



The Wilmington Housing Partnership and Wilmington Neighborhood Conservancy Land Bank began work this week on an East Side housing initiative supported by Delaware's Strong Neighborhoods Housing Fund.

Ten vacant, abandoned properties along Wilmington's Bennett Street will be demolished and replaced with 14 new three-bedroom townhomes, expected to be complete by early 2020. The new units will be aimed toward families earning 60 percent of the area median income.

[The Strong Neighborhoods Housing Fund last year awarded \\$645,000](#) to the Land Bank for demolition and other work. In total, Wilmington projects received \$2.1 million from the Fund, designed to fight blight and address vacant, abandoned or foreclosed properties.

“We’re very happy to see these investments paying off and creating the foundations for progress on the ground, making a real difference in people’s lives and in the life of a neighborhood,” DSHA Director Anas Ben Addi said at the demolition event this week.
