RSVP for Home4Good Stakeholder Meeting on June 10



The Delaware State Housing Authority (DSHA) and the Federal Home Loan Bank of Pittsburgh (FHLBank Pittsburgh) are pleased to announce the second year of Home4Good grants available to selected nonprofit organizations to support initiatives in Delaware that lead to stable housing for individuals and families who are homeless or determined to be at-risk of homelessness.

This collaboration allows activities previously supported by the Housing Development Fund (HDF) Housing Support grants to continue through the Home4Good program. DSHA and FHLBank Pittsburgh have contributed a combined total of \$1.2 million to the Home4Good program.

Governor Carney Hosts Ramadan Iftar Dinner at Woodburn



Governor John Carney hosted 30 guests at a Ramadan Iftar dinner at Woodburn, including members of Delaware's Muslim community and statewide elected officials.

The Iftar is the evening meal after sunset that concludes the daily fasting during the month of Ramadan, which ended on the evening of June 3. For observers, the Iftar dinner and Ramadan are a time to reflect on humanity and to reaffirm commitments to helping the less fortunate.

The event was the fifth Iftar dinner hosted by a governor of Delaware, renewing the tradition begun by Gov. Jack Markell in 2015. In attendance were representatives from six Delaware mosques as well as Lieutenant Governor Bethany Hall Long, Dover Mayor Robin Christiansen, Attorney General Kathleen Jennings, DSHA Director Anas Ben Addi and Department of Safety and Homeland Security Secretary Robert Coupe.
